# Head Chief Hammer de Roburt (Delegate)

Born - 25th September, 1922.

Educated Nauru Primary School and Junior Technical School, Geelong.

- 1940 Education Branch, Neuru Administration in clerical capacity.
- 1942 Transported to Truk by Japanese.
- 1946 Repatriated, and entered Nauruan Native Affairs Branch.
- 1951 Teacher, Nauruan Secondary School.
- 1952 Elected President, Nauruan Workers Organisation.
- 1955 Elected Councillor for Boe District and Head Chief Nauruan
  Council following Nr. Raymond Gadabu.
- 1956 Chairman, Nauru Lands Committee, resigned post as secondary school Teacher and appointed Manager Nauru Co-operative Society.

# Mr. Raymond Gadabu (Alternate Delegate)

Born - 25th September, 1921.

Educated Nauru Primary School, Geelong Junior Technical School, Gordon Institute of Technology, Geelong, and Everett's Business College, Melbourne.

- 1941 Appointed Ledger Clerk at Geelong and Crossy Trading Co., Geelong, and promoted subsequently to Shipping Clerk and Salesman.
- 1945 Appointed as Welfare Officer, Nauruans and other Pacific Islanders resident in Nauru.
