Overview

These *Results Highlights* describe some achievements of the Pacific Community (SPC) in 2017 against the *Pacific Community Strategic Plan 2016-2020*. SPC's Vision and Mission

VISION

Our Pacific vision is for a region of peace, harmony, security, social inclusion and prosperity, so that all Pacific people can lead free, healthy and productive lives. This is a shared vision for the Pacific under the Framework for Pacific Regionalism.

MISSION

We work for the well-being of Pacific people through the effective and innovative application of science and knowledge, guided by a deep understanding of Pacific Island contexts and cultures.

Priorities for 2017

In 2017, as SPC celebrated 70 years of operation, we planned to further consolidate our work and hone our areas of technical and scientific expertise, with a prioritisation process started in 2016. This work also involved improving SPC's business model to better leverage our position in the region and provide even greater value to our members in addressing their development challenges.

SPC's priority thematic areas identified in 2017

- Developing and applying fisheries science (to develop an 'area of excellence')
- Developing and applying plant and crop genetic resources (to develop an 'area of excellence')
- Regional education qualifications and assessment (a regional 'public good')
- Public health surveillance (a regional 'public good')
- Non-communicable disease
- Climate change and disaster risk resilience and management
- Oceans management and governance, and the development of a Pacific Community Centre for Ocean Science
- Regional data coordination and dissemination
- Human rights, including gender equality and youth
- Energy

The Pacific Community (SPC)

SPC is an international development organisation that has been serving the people of the Pacific since 1947. SPC is owned and governed by its 26 country and territory members: American Samoa, Australia, Cook Islands, Federated States of Micronesia, Fiji, France, Guam, Kiribati, Marshall Islands, Nauru, New Zealand, Niue, Northern Mariana Islands, Nouvelle-Calédonie, Palau, Papua New Guinea, Pitcairn Islands, Polynésie française, Samoa, Solomon Islands, Tokelau, Tonga, Tuvalu, United States of America, Vanuatu, and Wallis et Futuna.

Examples of results achieved in member countries and territories

AMERICAN SAMOA

1 statistical business register was established, through the South-South exchange; Fiji supported capacity development

COOK ISLANDS

Cook Islands Biosecurity Operations Manual, developed with SPC's support, was launched and is accessible online. The manual was developed under the SPC-supported regional biosecurity operations framework

FEDERATED STATES OF MICRONESIA

Emergency preparedness enhanced, such as sign-posting of tsunami safe area and evacuation routes in Pohnpei, and refurbishment of the Yap Emergency Operations Centre

FIJI

Tukuraki village was relocated due to cyclone impact, and the risk of future disasters. The new village site, built with support from SPC's Building Safety and Resilience in the Pacific Project, now hosts 11 wooden homes and 1 community hall, in line with best-practice disaster reduction strategies

FRENCH POLYNESIA

The Government committed to take up NCDs as a national health priority, through the **development of multisectoral NCD strategies and the establishment of an NCD Committee**

GUAM

The Public Health Laboratory of Guam has begun **process validation of gonorrhoea samples, as part of quality assurance protocols**

KIRIBATI

Kiribati Seabed Minerals Law was enacted in 2017, following two years of technical assistance from SPC's Deep Sea Minerals project

MARSHALL ISLANDS

The **national budget for gender** was increased, following sustained efforts of the national women's machinery and SPC mainstreaming support

NAURU

Nauru reported an **increase in women accessing emergency and support services**, making complaints to the police, and applying for protection orders around domestic violence, following SPC's legislation support, training and mentoring



NEW CALEDONIA

Integrated management of the Great South Lakes Ramsar area, with SPC's INTEGRÉ project support, to promote a sustainable development strategy

NIUE

Compliance audits were completed with SPC's support, to ensure minimum standards are met by national maritime bodies

NORTHERN MARIANA ISLANDS

Heath staff participated in **outbreak simulation exercises** facilitated by SPC, to improve responsiveness to disease outbreaks

PALAU

Development of **a community-based disaster risk reduction toolkit**, with SPC's support

PAPUA NEW GUINEA

SPC's Centre for Pacific Crops and Trees (CePaCT), in partnership with Papua New Guinea's National Agriculture Research Institute (NARI), successfully produced **4 new lines of taro varieties demonstrating resilience to disease and climate change**

PITCAIRN ISLANDS

Information support on disasters was provided by SPC to the Pacific disaster risk reduction community, including in Pitcairn Islands, through the Pacific Disaster Net and www.pdalo.net

SAMOA

Samoa submitted its **state report on the status of women**, as part of its reporting obligations under the United Nations Convention on the Elimination of All Forms of Discriminations Against Women (CEDAW)

SOLOMON ISLANDS

343 young people (137 females, 206 males) started their own businesses, following training and start-up support through the Youth@Work programme

TOKELAU

SPC facilitated South-South exchange between civil registration offices of Tokelau and Niue, which **increased Tokelau's understanding of civil registration processes and practices**

TONGA

1 forestry plan and associated regulations were launched: the Tonga Forest and Trees Management Plan (2017) and Sandalwood Regulations (2016) support sustainable forest management

TUVALU

SPC introduced **digital data collection technology** to support Tuvalu's 2017 Census of Population and Housing, and Tonga provided technical support through South-South exchange

VANUATU

SPC supported Vanuatu to **develop community-based fisheries management plans**, to support local management of inshore fisheries and aquatic resources

WALLIS AND FUTUNA

A sustainable waste collection and shipment activity was set up, with nearly 300 tonnes of batteries and 200,000 litres of used oil shipped for processing and re-use in New Zealand for the first time

Highlighted partnerships

Examples of partnerships that were nurtured in 2017 to advance the development objectives of PICTs

Council of Regional Organisations in the Pacific (CROP) agencies

- SPC and SPREP developed a joint multi-year Resilient Pacific Programme, to support the development objectives of both organisations' members
- SPC and SPREP established and launched the Maritime Technology Cooperation Centre
- Phase 2 of the Regional Culture Strategy 2017-2020, and Investing in Culture 2010-2020 initiatives, was developed with PIFS, SPREP, USP and the SPTO (and other organisations)
- Multiple agency country missions were conducted by SPC, PIFS and SPREP (among other agencies), to support country work plans
- Governance arrangements for the Framework for Resilient Development in the Pacific (FRDP) were endorsed during the Pacific Islands Forum Leaders meeting

SPC collaborated with the World Bank Group

- to provide data to the Global Tracking Framework on sustainable energy
- on household income and expenditure survey (HIES) data collection
- to monitor the implementation of the Pacific Early Age Readiness and Learning (PEARL) programme, to improve child learning and teacher training

SPC collaborated with United Nations agencies (FAO, UNDP, UNESCO, UNFPA and UNICEF)

- to finalise the Regional Framework for Pacific Agricultural Statistics (P-SPAFS) (with FAO)
- to prepare a comprehensive five-year regional plan for statistical collections (with UNFPA and UNICEF)
- to provide well-coordinated and well-planned technical support for the conduct of national statistical collections (with UNFPA, UNICEF)
- to implement the Wake Up! Youth project: advocacy and health messaging on NCD prevention and control (with UNDP)
- to conduct joint missions with UNESCO to provide recommendations for improving evidence-based decision-making

SPC collaborated with other regional research organisations (ACIAR and ACER)

- to collect data on value chains for food production systems (with ACIAR)
- to trial and test Pacific Islands Literacy and Numeracy Assessment (PILNA) instruments (with ACER)

SPC collaborated with private sector and civil society stakeholders

- to develop the disaster-ready toolkit, with PIPSO and the Fiji Business Disaster and Resilience Council, and support from the EU and USAID, to improve business resilience
- to advance gender equality in government, labour rights, right to information, youth development, and disability objectives with civil society networks



SPC's contributions to the SDGs

The 2030 Agenda for Sustainable Development presents opportunities for SPC to support regional efforts to improve national statistical systems. SPC:

- is a member of the Pacific SDG Taskforce, which established the Pacific Roadmap for Sustainable Development 'to guide and consolidate the region's efforts to implement and monitor the 2030 Agenda and SDGs, SAMOA Pathway and Framework for Pacific Regionalism'
- developed, with PIFS and PSSC, a Pacific set of sustainable development indicators
- collated a region-wide matrix to identify SDG baseline data availability by country to inform the first Pacific Report for Sustainable Development being prepared for PIFS Leaders' consideration in 2018
- assisted countries to undertake national statistical capacity and systems assessments, to improve national statistical systems
- with WHO and other partners, developed the Pacific Healthy Islands Monitoring Framework, to monitor progress in implementing the Healthy Islands Vision. The framework's aims include alignment with SDG indicators
- worked closely with Pacific MANA and other partners on other SDG health indicators, particularly around health security and human resources for health

Looking ahead

2018 will be an important year for SPC, as we engage in our mid-term review of our Strategic Plan. We will shape our future direction based on evidence about what has worked well, and areas that need improvement, and how SPC's work fits with changing development contexts. SPC's divisions and programmes will update their business plans, reflecting the findings of the mid-term review. The Government of Sweden partnered with SPC to support its human rights programme through a multi-year flexible funding agreement
